

Product

Everdry Undertile Heating is an electric heating system intended for floor surface warming of stone and ceramic tile finishes in residential and commercial buildings, including wet areas.

Scope

- 2.1 Everdry Undertile Heating has been appraised for use in internal wet and dry areas of buildings, within the following scope:
 - · on a structural substrate of concrete, plywood or fibre cement compressed sheet (excluding particle board flooring); and,
 - · with fibre cement tile underlay where required; and,
 - · when protected from physical damage by a screed and ceramic or stone tiles; and,
 - where floors are designed and constructed such that deflections do not exceed 1/360th of the span; and,
 - · where the position of movement and control joints within the substrate are accounted for and reflected in the screed and ceramic or stone tile finish; and,
 - where floors are designed not to exceed a continuous operating temperature of 35°C.
- 2.2 Everdry Undertile Heating must be finished with a stone or ceramic tile floor covering. Stone and ceramic tile finishes are outside the scope of this Appraisal.
- 2.3 In wet areas, a membrane system that meets the New Zealand Building Code and is deemed compatible with heated floors is required. A BRANZ appraised internal wet area membrane may be used for this application. The design and application of the wet area membrane system is outside the scope of this Appraisal.

Building Regulations

New Zealand Building Code (NZBC)

In the opinion of BRANZ, Everdry Undertile Heating, if designed, used, installed and maintained in accordance with the statements and conditions of this Appraisal, will meet or contribute to meeting the following provisions of the NZBC:

Clause B2 DURABILITY: Performance B2.3.1 [b] 15 years and B2.3.1 [c] 5 years. Everdry Undertile Heating meets these requirements. See Paragraph 8.1.

Clause F2 HAZARDOUS BUILDING MATERIALS: Performance F2.3.1. Everdry Undertile Heating meets this requirement.

Clause G9 ELECTRICITY: Performance G9.3.1. Everdry Undertile Heating meets this requirement. See Paragraphs 10.1 and 13.1

- 4.1 Everdry Undertile Heating is electric element heating cable embedded into a screed or levelling compound over various substrates and finished with stone or ceramic tiles. Temperature is controlled by a floor sensing Everdry programmable thermostat. The heating products and accessories used in Everdry Undertile Heating, supplied, or specified by Everdry Limited are as follows:
 - Everdry Thermostat programmable touchscreen thermostat with WiFi capability.
 - Everdry Heating Cable single strand single resistance conductor, FEP insulation, CuSn Braid screen earthed, with an outer PVC insulation. Heating elements are factory terminated and available in different sizes.

Handling and Storage

5.1 Everdry Undertile Heating components must be stored inside, in dry conditions.

Technical Literature

- 6.1 This Appraisal must be read in conjunction with:
 - S-Cable Installation Manual, Version 1, dated 10 January 2024.
 - Everdry Detail Drawing Set, Version 1, dated 01 March 2024.
- 6.2 All aspects of design, use, installation and maintenance contained in the Technical Literature and within the scope of this Appraisal must be followed.

Design Information

General

7.1 Everdry Undertile Heating is a low temperature, electric floor surface warming system. It is suitable for use in most internal tiled areas of buildings where floor warming is desired. It is also suitable for use in wet areas, including shower areas, provided an appropriate wet area membrane system is used.

Heating Design

7.2 The layout of the electric element cables must be carried out in accordance with the Technical Literature published by Everdry Waterprooding Limited.

Wet Area Membrane

- 7.3 A wet area membrane that meets the relevant requirements of NZBC Clause E3 Internal Moisture and is deemed compatible with heated floors must be used in all wet areas.
- 7.4 A BRANZ appraised internal wet area membrane may be used for this application.
- 7.5 The selection, design and installation of the membrane system are outside the scope of this Appraisal. Further guidance on wet area membranes can be obtained from section 1-4 of the Waterproofing Membrane Association NZ Inc. [WMAI] Code of Practice for Internal Wet Area Membrane, as referenced by E3/AS2.

Durability

Provided the system is installed and maintained in accordance with the Technical Literature published by Everdry Waterproofing Limited, Everdry Undertile Heating will provide a serviceable life of at least 15 years under normal operating conditions. The thermostat is readily accessible for servicing should it be required.

Maintenance

9.1 No servicing of the electrical elements should be required unless damage has occurred. Should the tile surface require repairs, Everdry Waterproofing Limited must be contacted prior to any work commencing. Any electrical repairs must be carried out by a registered electrician.

Electricity

10.1 Electrical components used in Everdry Undertile Heating meet the requirements of the Electricity [Safety] Regulations 2010 for electrical safety of fittings and electrical appliances.

Installation Information

Installation Skill Level Requirement

- 11.1 All installation work must be carried out in accordance with the Everdry Undertile Heating Installation Manual and this Appraisal by competent and experienced tradespersons conversant with loose cable under tile heating systems.
- 11.2 Everdry Waterproofing Limited will provide training and further information on request. It is the responsibility of the installer to seek quidance from Everdry Waterproofing Limited where required.
- 11.3 Installation of the electrical wiring and components must be carried out by a registered electrician.

General

- 12.1 Substrates must be dry, clean and stable before installation commences. Surfaces must be even and free from nibs, sharp edges, dust, dirt or other materials such as oil and grease. All voids, cracks, holes, joints and excessively rough areas must be filled to achieve an even and uniform surface.
- 12.2 The Everdry heating cable must not be cut. The Everdry Undertile Heating Installation Manual provides guidance on selecting the correct length cable for a given floor area.
- 12.3 The Everdry heating cables must be spaced a minimum of 50 mm apart and should maintain 100 mm distance from floor/wall junctions and permanent floor mounted fixtures.

Basis of Appraisal

The following is a summary of the technical investigations carried out.

Tests

13.1 An assessment of electrical safety in compliance with IEC 60800:2021 and IEC 60730-2-9:2015 has been carried out.

Other Investigations

- 14.1 The Technical Literature, including installation instructions, have been reviewed by BRANZ and found to be satisfactory.
- 14.2 Site inspections were carried out to assess the practicability of installation.

Quality

- 15.1 The manufacture of the Everdry Undertile Heating components has not been examined by BRANZ, but details regarding the quality and composition of the materials used were obtained by BRANZ and found to be satisfactory.
- 15.2 The quality of supply to the market is the responsibility of Everdry Waterproofing Limited.
- Designers are responsible for the building design, and building contractors are responsible for the quality of the installation of the structure, framing systems and the substrates.
- 15.4 Quality of the on-site installation is the responsibility of the building contractor.
- 15.5 Building owners are responsible for the maintenance of the system and the ceramic or stone tile finish.
- 15.6 Electrical components that connect to mains power must be installed by a registered electrician.
